Baker called meeting to order 11:30

<u>Introductions:</u> The new student commissioners, Hannah Hilgeman and Eduardo Canales were introduced. Schorzman explained that we will have two students, one a senior and one a junior — as a commissioner in training — to develop experience and participation. Baker asked that the students find areas to focus where they believe they will have the most impact. Burns introduces Chelsee, the new History Fellow.

#### **MOTION 1: Minutes**

- Chandler moved to approve June minutes. Ochoa seconded. Motion Carried
- Ryan moved to approve the August minutes. Motion carried.

## Reports

Public Art - Karen Bubb

Karen Bubb introduced deaccession requests for Veiko Valencia's Little Free Library and Ward Hooper's mural Wheels. Bubb provided detailed information regarding the process of deaccession. Valencia's little free library burned in the International Market fire.

**MOTION 2: Deaccession --** Hardy moved to approve the deaccession of Valencia's Little Free Library. Seconded. Motion Carried.

Bubb stated that Rhoades Skate Park is being redone and artists on the redesign team requested to redo the existing Ward Hooper mural. Hooper was in support of the removal. Staff recommendation is to fully remove and deaccession the mural. Hale inquires if the mural will be painted over. Bubb responded that it will be sandblasted and fully removed before being painted over.

**MOTION 3: Deaccession --** Chandler moved to deaccession Ward Hooper Mural. Seconded. Motion Carried.

Bubb reported that the Northwest Public Art conference started that evening and provided details of the schedule. Hardy and Baker requested more information. The temporary public art for the conference was postponed until FY16. The Little Free Library, a project of the public art academy, is now installed at Roosevelt Market.

Bubb stated that the Cultural Plan is progressing and should be ready before the next commission meeting. She also noted that City Council denied the protest of the Fire Station public art going to an artist from outside of Boise. The projects will go the local artists. Bubb shared the statistics of the Public Art Program and invited commissioners to the Art at City Hall opening on Oct. 22, 4.00-6.00.

Cultural Programs — Amy Fackler

Fackler distributed the Grant Program events calendar and noted that the online review form is now available. Baker stated that she appreciates the work that Fackler has done for the evaluations of the grant program and encouraged the student commissioners to attend and provide feedback for the grant events.

Chandler inquired if a grant went to BCT. Schorzman responds that they did not apply. Fackler added that the department is working to promote the grant recipients through interviews and social media. Fackler would like to generate tangible results for council. Schorzman stated that the grant program will be 20 years old in FY17 and would like to see an increase in the grant budget.

Cultural Assets - Josh Olson

Olson stated that the River Sculpture renovation was nearly finished. Olson provided an update on the progress and remaining steps to finish the project. He noted the one issue remaining is the drainage and is working to resolve the issue. Baker inquires about an opening. Olson stated that all parties are satisfied with the results thus far and that all relationships are still in good shape...and that no dedication is planned. He did request, however, support from the commission to tout the success of the River Sculpture renovation and to also refer to it by its proper name and treat it with respect. Baker concurred that we promote its success.

Olson reported that there is an issue with the Julia Davis Sculpture, which was removed and re-installed without A&H being notified. There are issues with the new base. He is working to resolve the issues. Hale inquired if the work is our responsibility. Olson stated that he wants to do the reinstall properly.

Olson states that Great Blues has been very well maintained by Government Buildings and wanted to give thanks to all of the partners who help him. Olson said that he has been pushing to get the entire public art collection cleaned up and presentable for the conference.

History Programs — Brandi Burns

Burns reported that she is still working on *Boise: an Illustrated History* and expects it to be published by the Fall of 2016 and gave an update on the Fettuccine Forum season. Chandler stated that she appreciates the work being done for the success of the Forum. Schorzman noted that the Forum has been successful at City Hall.

Communications and Community Engagement – Rachel Reichert

Castle project: Reichert stated that the James Castle Home site is going well. Hundreds of hours have been spent on site clean-up thanks to the Mark Baltes and Byron Folwell. The rotten/decaying trees were removed. Fred Walters (architectural historian through the Idaho Heritage Trust) was on site to do architectural assessments. We received the conditional use permit, have submitted a grant application for the bunkhouse restoration and are exploring grants for the dream cottage and the house. The budget is being solidified now to take to council.

Website: Reichert stated the new website should be ready to show in beta form by the next meeting. Baker inquires about the new public art brochure. Reichert stated that the brochure project is back on track. Schorzman states that we have just hired a temp employee to help Reichert with communications as she focuses more on James Castle.

Schorzman reported that the Economic Impact study by Americans for the Arts was done in 2010; the impact in the non-profit sector in Boise was \$48m. It missed, however, activity in the private sector. Staff decided to pursue the Creative Vitality Index instead, offered by the Western States Arts Federation. It will provide a well-rounded look at how Boise stacks up in the creative sector. The analysis will commence in November.

The end of the fiscal year (9/30/15) included a focus on year-end budget close, personnel reviews, preparation of an Individual Development Plan, and general assessment.

I met with our new fundraising person to explore options for pursuing additional funding for A&H initiatives, including the James Castle Home Site project. I joined a city team to share our project ideas with the Idaho Women's Charitable Trust, explored idea of establishing a 501 (a Friends of Arts & History type structure) vs. setting up a dedicated gift fund. We'll establish the gift fund soon.

Other key administrative work included assessing and purchasing the services of the Western State Arts Federation to prepare and deliver for the city a specially-tailored analysis of our creative sector — the Creative Vitality Suite (CVS). The data will supplement and assist our economic development director and his Boise Competes project (i.e., the CVS will add new data to his project in areas that were difficult to obtain).

Also, we selected and notified the first 13 members for the new Arts & History Advisory Team, and hosted the first training session on November 16.

I continue to review and/or participate on several key department projects as well as citywide teams:

- Cultural Plan provided edits and prepared text for new section; hired professional to review plan
  and recommend any changes before being offered for public review;
- Vista Energize project much work proceeding here with completion of report on Vista history, several oral history interviews, preliminary design for Gateway, more BSU student engagement for special alley clean-up and long-term options;
- The Broadway Bridge historic mitigation project —helping determine locations for interpretive signs;
- LIV/Sustainability report provided information for report;
- Served on the grant panel for the Idaho Heritage Trust annual review;
- Attended some of the two-day historic site assessment for the Castle site;
- Attended the Northwest Public art conference hosted by A&H;
- Attended the city's Leadership Summit;
- Attended our Art at City Hall public open house;
- Approved the final design for the Mayor's Wall, to be installed on 3<sup>rd</sup> floor.

#### **NEW ACTIVITY**

- Linen District Fence: Call out. Deadline December 10<sup>th</sup>.
- <u>Public Art Academy:</u> The call for applicants is out. Deadline is December 18<sup>th</sup>. 20 will be accepted.
- **De-accessions**: Wheels by Ward Hooper & Little Free Library by Veiko Valencia pulled from City Council agenda for further discussion.
- <u>Boise Cultural Plan:</u> Amanda Ashley is reviewing and editing the plan prior to providing it to readers for review.
- <u>Boise WaterShed:</u> Byron Folwell, Matt Grover, Reham Aarti, and Michael Anderson designs approved by Boise City Council. Dan Snow approvals delayed until we know if we can fund.
- **Boise WaterShed**: Amphitheater Artist: Dan Snow came to Boise in October for stone stacking workshops. The resulting walls are beautiful and will be part of the final design.
- Four New Fire Stations: Byron Folwell and the team of Dixon/Baltes/McCall selected. Designs in process.
- Library! At Bown Crossing: \$60,000 Janet Zweig of Brooklyn selected by the panel. Project in design.
- NRG: Movable Art Project for neighborhood association. Ken McCall was selected for the project.
- <u>Traffic Box Art Wraps 2015:</u> ON HOLD. Fabricator call re-bid. Four applications received. Panel meeting in December. Projects from last year will be completed in the Spring.

## **IN PLANNING STAGES**

• <u>Temporary public art:</u> Three teams from the Public Art Academy class were selected to do projects. Karl LeClair will be managing these projects.

## **WORKS IN ACTIVE DESIGN/FABRICATION**

- <u>Valley Regional Transit Center's Multi-Modal Center:</u> Contracts underway for 5 projects. Selection panel meeting to review applications to the entrance wall opportunity. Eleven applications received.
- Public Works/Boise WaterShed: Amy Westover working on the design team.
- Boise City Hall Public Art on the Plaza: \$200,000 CTA Studio & Ecosystem Science design initiated.
- <u>Public Works/BSU Geothermal Theme</u>: \$25,000 PW & BSU are partnering to create an artwork on BSU campus that celebrates geothermal water at BSU. Leslie Dixon and Ken McCall selected.
- <u>Little Free Libraries:</u> \$3,000, 1 teams working on finishing "Little Free Libraries" for neighborhoods.
- <u>Whitewater Boulevard Roundabout Art:</u> \$30,000. Mayor's Neighborhood Reinvestment Grant Program, Dirk Anderson, selected and working on fabrication of sculpture.
- Whittier Elementary Artful Fence: \$38,000, design phase, Dennis & Margo Proksa working on design.

## **OTHER - INFORMATIONAL REVIEW**

- <u>Public Art Network</u>: Boise hosted the regional public art administrators' conference October 15–17. Fifty people attended. It was a great success. Thanks Alecia for helping us with the conference!
- <u>Deaths in the Arts Community</u>: We lost three local artists to cancer since we met last. Bob Neal, graphic designer and visual artist whose work is in our collection, spouse of Jeanne Huff (writer). Geoffrey Evert, a painter in Boise, husband of artist Nancy Panganiban (visual artist). And Alvin Greenberg, writer and spouse of Janet Holmes (writer).
