This juried show will feature area artists in a variety of fine art media. 30% of all sales will go directly to the WCA. We will also be hosting an evening event and opening reception on Thursday, September 15 from 6-9 featuring music, live and silent auctions and a raffle to benefit the WCA, wine and hors d’ouvres. The Juried Show will hang September 15-October 1.

Eligibility: Artwork should depict the theme: “Hope”. Artists working in Fine Art Media such as Painting, Sculpture, Pottery, Glass, Mosaic, Mixed Media and Photography are eligible to apply. There is a jury fee of \$20 for up to three submissions.

September 5: Notifications of acceptance will be emailed to the artists. If you do not receive a notification by midnight, September 6, please contact Zella Bardsley at 208-378-1464 or zellabardsley@cablone.net.

September 8-10: Accepted artwork to be delivered to Art Zone 208 between 10 am and 5 pm. *Show will be hung on September 13-14. If you are unable to deliver during those times, please contact Zella Bardsley to make arrangements.*

September 15-October 1: Exhibit hangs at Art Zone 208; open Tues-Sat, 10-5.

September 15: Opening Reception and Fundraising Event! 6-9 pm. Awards will be announced at 6:30. Live and Silent Auctions, Raffle, music, food and wine. This is a ticketed event. Artists will receive one ticket. Additional tickets are \$10 at the door.

October 1 or 4-8: Pick up your unsold artwork at Art Zone 208 between 10 and 5. You will be notified of sales before October 1.

October 15: Checks for sold work will be mailed to the artists. Note that 30% of the sales price will go directly to the WCA.
