

# Meeting Notes

#### Call to Order:

Commissioner Ochoa called to order at 3:30 p.m.

## **Approval of Minutes:**

Motion to approve the December 6, 2017 minutes. Ryan moved. Heathcock seconded. Motion carried unanimously.

#### Administration:

Jennifer Tomlinson, Parks Resource Superintendent, presented on the progress of Spaulding Ranch. The property was acquired by the City in 2016. Parks is currently in the concept development and gathering input from the community. The main goal is to preserve the site in general—keep the farm and have apple orchard. Funding has been identified for FY21. There is a consultant in place helping with the program development implementation. The Forestry Division is developing a plan for the orchard. Also, Parks is currently looking at plans to rehab the structures.

Terri provided an updated on the Library/Arts facilities. Safdie Architects was the architect selected from five teams. Concept designs will be ready for review sometime mid-late March. AMS will be under contract for the development of the Performing Arts Center piece of this project.

## Reports:

Care and Conservation – Josh Olson

• Request for approval for the deaccession of the roundabout mosaic mural by the Depot Bench. Ochoa presented a motion to approve the deaccession of the mosaic. Baker moved. Ryan seconded. Motion carried unanimously. This will go to council once there is a plan for the site.

#### Public Art – Karl LeClair

- Request for approval of three media projection projects, two performances and two interactive
  installations that will occur during Treefort event days. Karl showed images of various projects to
  the group. He requested approval of the seven projects as presented. Ryan moved. Heathcock
  seconded. Motion carried unanimously.
  - Request for approval for the purchase of comic con panels. We received only one applicant, Steve Willhite. Karl showed slides of his work and requested approval to purchase the four works. Flynn moved. Ryan seconded. **Motion carried unanimously.**

- Request to approve the purchase of three (3) art work pieces by Troy Passey to be added to the portable works collection. These works are part of the James Castle House collection by Troy Passey. These images will be displayed in the book Troy is working on. Each piece will be purchased for \$1,700 total. Baker moved to approve the purchase as presented. Ryan seconded. **Motion carried unanimously.**
- Update on the Basque Mural. The mural was officially deaccessioned. Contracts will be drafted soon to hire the artist to paint a new 3X12 replica from to keep in our BVC collection. Thank you Jennifer Yribar for helping with the news release.
- Commissioner Baker asked about the degradation of some existing traffic boxes wraps. Karl indicated two re-wraps will be completed this year; others were re-wrapped before January 2018, including one at BSU.
- Update on Vista Median Art Project. The city has selected three finalists (Amy Westover, Cecilia Lueza, and Ide Russell). Their proposals are expected in April.
- Update on James Castle House "signifier" Public Art. Sixteen applications were received. They will be evaluated.

#### James Castle House – Rachel

- Final inspection of the house on 2/7/18; received temporary occupancy certificate. Will start moving the next day. Currently building website for the James Castle House along with brand development.
- Plans for the various events as part of the symposium (April 25-28) are underway. Official opening date is April 28, 2018. We will be holding a free event at the Egyptian Theater on Thursday, April 26
- Rachel introduced Kristen Hill, Cultural Sites Program Coordinator.

#### James Castle House Artist in Residence – Kristen

- First artist coming in May for three months duration.
- The James Castle book has been completed. It will be for sale at the James Castle retail shop.
- The "pilot" artist in residence program will start on February 23<sup>rd</sup>. Three artists will do one week each—Troy Passey, Jeff Krueger, and Karen Woods.
- April 5<sup>th</sup>, event at Ming Studios—Exhibit of the James Castle book by Troy Passey.
- Currently planning for the 10<sup>th</sup> year anniversary celebration of the Arts and History Department. We have set aside April 14, 2018 for this event. More details to come; mark your calendars.

#### Cultural Plan Update – Karen Bubb

- Working with Boise Downtown Association to hold a cultural event on April 10. Will have more information about this event later on.






## **Summary**

Currently the City of Boise has an estimated 650 assets in the collection(s) valued at nearly 5.8 million dollars. Winter is excessively hard on our collections and spring is a busy time. The increase in construction and human activity has kept us on our toes. Special thanks to Airport, Public Works, Parks and Recreation, IT, PDS and Government Buildings for their efforts to assist in the care and conservation of these one-of-a-kind city assets.

#### Current

- -Vue Works: Working closely with our IT department to develop a Special Asset and Facility Management program that will track A&H work orders and inspections, maintenance costs and activity of all 600 art assets.
- -Contracts in place for 168 traffic box locations for cleanings and graffiti removal.
- -Contracts in place for general painting maintenance needs.
- Great Blues Water Feature: Seasonal maintenance and turn on. Assessments of damaged concrete basin
- -Boise Watershed Headwaters and Flux water features: Seasonal maintenance and turn on. Contractor hire for repairs pending approval.
- -American Cleaning Contract for airport glass art renewed.
- -Franz Whitte Landscaping renewed April 2018
- -Clearview River Sculpture Cleaning contract renewed
- Public Art Signage for 167 traffic Boxes and 8 for public art locations
- Temperance Fountain restoration: City Hall Plaza
- -Various corrective maintenance to over 25 public art installations

# **CULTURAL MASTER PLAN (CMP) IMPLEMENTATION: CULTURAL PLAN PROJECTS**


In February and March Bubb focused on two primary goals. Below are projects to further these goals.

## Goal 2: Enhance & Preserve Neighborhood Places: Strategy 2.3 Localize Cultural Planning

- Investigating Arts & Cultural Impact on Downtown Boise
  - Partnered with BSU to conduct a survey of downtown businesses
  - Conducted interviews of downtown business owners concerning value of the arts & culture for downtown
  - Translated the Cultural Vitality Index in ways that can be used to understand the vitality of culture downtown
  - Helping prepare for "State of Downtown" event on April 10<sup>th</sup> and a publication for the Idaho Business Review
  - Organizing non-profits for tables at the April 10<sup>th</sup> event
  - Organizing a book signing at Rediscovered Books at 7pm on April 10<sup>th</sup> with speaker Dar Williams
- James Castle House | A Place Called Home: Inaugural Symposium
  - Planning and implement a three-day symposium and opening event for the James Castle House April 25 28.
- Hayman House: Making a Place for Immigrants, African-Americans, & New Americans
  - Presented to Boise City Council to get approval of Capital City Development Corporation conveyance of the house to Boise City in the Spring of 2018.

# **Goal 4: Foster Organizations & Partnerships:**

- Regional Collaboration: Two Counties Converge around Culture
  - Interviewing municipal arts leaders
  - Inventorying current cultural conditions in Ada and Canyon County
  - Planning Treasure Valley's first regional cultural summit to be held May 23<sup>rd</sup> 2018
  - Researching Cultural Tourism plans in other communities that could be models for ours
- First Peoples: An Intersection of Social Justice, Urban Environment, & Cultural Planning
  - Working with the Native American Tribes to develop a plan to create physical markers such as public art, restoration of Native place names, interpretive signage, or other exhibitions or monuments. A meeting date is set for March 30<sup>th</sup> with Tribal leadership, to be followed by support for their Return of the Boise Valley People event in June and further meetings.

This quarter the archives program remained busy communicating with donors and various municipal departments about the intent of the archives program. Work also focused on making significant progress on existing long-term projects.



We continue to catalog and rehouse artifacts, as well as gather research about the items in our collection. Our oral history work continues; we received two interviews from volunteers in the Highlands community.


