Goal 1: Develop Cultural Policy

• **PhD Studies:** I am reading multiple books and writing about the intersection of cultural, economic, and urban policy as part of my studies. I am exploring how to transfer this information into useful applications for the City of Boise.

Goal 2: Enhance and Preserve Neighborhood Places

SUMMARY

This quarter's work was concentrated at the James Castle House (JCH) and Erma Hayman House (EHH). The James Castle House has reopened for scheduled in-person tours held weekly on Fridays and now offers weekly virtual tours. Staff are focusing on completing program and facility planning documents and are engaged in various research projects for both the JCH and EHH. Cultural Sites Manager will present on Artist Residencies At Historic Sites for the AASLH conference in September.

JAMES CASTLE HOUSE

The JCH is preparing to submit museum accreditation application to the American Museum Association. Staff are planning a virtual meeting series to assist with long-term planning efforts for the historic shed and trailer on site.

RE: Public Art Maintenance and Conservation

Preventative and Corrective Maintenance: Inspections, cleaning, graffiti removal and repairs are ongoing for the City of Boise's 940 locations of public art and cultural collections. Downtown has a seen a surge of graffiti and vandalism as well as calls for permanent removal for development and damage from construction.

Litharacnium: BODO sculpture on 8th street was severely damaged by a cement truck. The sculpture required immediate removal and will require extensive repairs. Project pending.

-Bronze Sculptures: Up to eight bronze sculptures will have extensive surface cleaning and patina restoration completed

-**Untitled sculpture in BODO:** McCall Studios is a local fabrication/ public art studio that has been hired to restore and reinstall the sculpture. Sculpture was successfully restored and reinstalled.

-Untiled Stained Glass: The City of Boise received this artwork as a gift from CCDC in early 2003. It was originally installed at 225 N 9th street and remains there today. The building has a new owner, and they would like to have the public art/stained glass by Michael Pilla removed permanently. The artwork is temporarily in storage but plans to permanently deaccession the artwork will likely commence in FY22 if a suitable location can not be found.

Gem Block Circles: Ward Hooper worked directly with CCDC to develop a decorative component to a seating area on Main St between 11th and 12th. The seating area was gifted to the City this year and then we received a prompt request that the Avery Hotel development would like it removed for parking purposes. As all options have been explored, the cost to remove and relocate are to expensive. The decorative features will be deaccessioned in FY22 at the cost of the developer.

-Three Deer sculpture in Anne Morrison Park: The Three Deer are one of the most popular sculptures in Anne Morrison Park. The deer will be relocated during a large-scale park renovation. Once completed, new enamel will be applied by Rick Friesen will complete restoration.

-Traffic Box Contract: Primo Cleaners, has been hired for general routine cleaning of all 250+ traffic boxes for fy21. Due to extensive graffiti and slap tags highlighting the former Presidents departure from office a change order was established for the team to clean the artworks in January.

SUMMARY

History Division is focusing most staff efforts on website content creation and creating a space online to share the collections in the Boise City Archives. Watch for our interesting content on social media!

CURRENT & PAST PROJECTS

- Website:
 - Several pages for Boise mayor biographies are created and ready for publishing; IT implemented a nesting grid system so we can better organize content; a short history of Boise is in the works; Fettuccine Forum video page is in the works
 - Quartex: Worked with Archives Program to select Quartex for online collections interface. Implementation will follow in FY22.
- Walking tours:
 - November 3, 2021: "Lay Me Down on a Bed of Roses": Boise Suffragists in Their Final Resting Places
 - Self-guided contemplative visit to Boise's cemeteries and the graves of Idaho suffragists. This event is meant to honor the lives of the women who worked to secure the vote for Idaho women and who are now in their final resting place.
- Development of online exhibits, podcast, and articles
 - o These materials will be added to the "Boise history" section of the website
 - Content includes an article about Boise's city halls, the establishment of Boise as a municipality, fires in downtown Boise, and a series of biographies of Boise mayors. Fettuccine Forum videos will also be uploaded

SUMMARY

Archives program is focused on auditing collections and accession paperwork against the collections management software to gain a better understanding of what collections are in the archive, assess backlog, prioritize processing projects and preservation concerns. Worked with History Program Manager and IT to sign contract with Quartex, the new online interface A&H will use as an access and outreach tool. Worked with communications team to develop plan in celebration of Archives Month.
