Boise City Seeks Artists to Implement a Variety of Short-Term Public Art Projects During the 2020 Treefort Music Fest

DEADLINE: 4 November 2019 at 1:00 pm Mountain Standard Time

INDIVIDUAL PROJECT BUDGET: \$100 - \$5,000 per project, multiple projects

OPPORTUNITY

In Partnership with Treefort Music Fest, the Boise City Department of Arts & History invites artists to submit an application for the opportunity to implement a project during Treefort Music Fest in 2020, scheduled for March 25th – March 29th. The project must occur during these dates, but the total duration of the project may extend beyond the festival's schedule. Execution timelines will be negotiated based on each individual project. The goal is to commission innovative projects that engage a diverse public audience in order to activate locations throughout downtown Boise. New or existing work may be submitted for consideration. The theme is open, but the content must be appropriate for all members of the public. We will accept submissions from a variety of disciplines, but are particularly interested in funding the following categories:

- New media projects (light/ projection installations, projection mapping, etc.)
- Fine art performances (pop-up performances, street performances, happenings, etc.)
- Interactive or participatory projects or installations

The selection panel may select as many artists or artist teams as they see fit. Each project's commission or budget request may vary, depending on the project's specific needs. The maximum amount the artist may request is \$5,000. The selection panel may choose to support several smaller-budget projects as well as projects of a larger budget. Multiple applications with varied project budgets may be submitted.

STATEMENT ON DIVERSITY, EQUITY AND INCLUSION

In 2017, the Arts & History Commission endorsed a statement on cultural equity. In recognition of the initiative, the Department of Arts & History will strive to accession works into the collections which serve to reflect the rich and diverse past, present, and future of the Boise community.

"To support a full creative life for all, we commit to championing policies and practices of cultural equity that empower a just, inclusive, and equitable nation." Cultural equity embodies the values, policies, and practices that ensure that all people—including, but not limited to, those who have been historically underrepresented based on race or ethnicity, age, disability, sexual orientation, gender, gender identity, socioeconomic status, geography, citizenship status, or religion—are represented. Cultural equity is critical to the long-term viability of the arts sector. The prominent presence of artists challenges inequities and encourages alternatives.

PROJECT BACKGROUND

The goal of these projects is to highlight the contemporary art community while providing a unique and diverse platform for artists to execute and display original artwork. These projects will occur as a part of Treefort Music Fest's Artfort with the directive of amplifying Boise's creative culture and broader art scene. This is exemplified by past efforts established through Treefort Gallery, pop-up dance performances, mural installations, and more.

The partnership between Treefort Music Fest and the City of Boise's Public Art Program was first initiated in 2017 and resulted in a series of diverse projects; some of which resulted in cross-over collaborations. For example, during Treefort Music Fest 2019, a choreographer duo initiated a contemporary dance piece inspired by an interactive art installation. The artwork served as a background for the pop-up dance performance.

PROJECT INFORMATION

Artists will apply for the opportunity to develop a project for Treefort Music Fest. Once selected as a finalist and placed on contract, the artist or artist team will begin developing the project with the guidance of the Department of Arts & History and Treefort Music Fest staff, as necessary. This process will result in a project proposal that will contain a project timeline, a detailed budget, project renderings or other visual examples, and a project description; during this process, the project location will be finalized. Artists will be required to provide all tools, equipment, technology, knowledge and labor necessary to successfully execute the proposed project.

Staff may assist the artist to determine a location that suits the needs of the project. However, applicants will actively search for or suggest a location that may be best suited for the final vision. Locations must be fully (ADA) accessible and provide a free experience to all members of the public. All projects will occur within the Treefort Music Fest footprint to encourage maximum impact and visibility. For specific projects, such as murals or installations, it is at the discretion of the City to potentially assign a location.



EVALUATION PROCESS

The City of Boise reserves the right to reject any and all applications, to waive any irregularities in the applications received and to accept the applications that are in the best interest of the City. Boise City is an Equal Opportunity Employer. The City of Boise is exempt from Federal and State taxes and will execute the required exemption certificates.

Applications will be reviewed by the Evaluation Panel, which is made up of Treefort Music Fest staff, an Arts and History Advisory Team member, an Arts & History Commissioner, and two artists. The Application package shall contain the following information:

1. Application Form

Fill out and sign the **Application Form**/ Signature Page and submit as your first document. Be sure to indicate your general budget request for the project (\$100 - \$5,000).

2. Project Description

Describe, in detail, the proposed direction for the project. The written description should not exceed 2 pages. A final proposal will be created during the Project Development phase. The final proposal will be expected to build upon/ develop from the project description.

3. Artist Resume

Include a resume and / or brief summary of the Artist or Artist Team's qualifications and / or past experience. Emerging artists are encouraged to apply.

4. JPEG Images or MP4 Video of current and past work

Images are to be in JPEG Format, 300 dpi, not larger than 10" on the longest side.

Provide up to ten images of your past work, current work, and/or images of the proposed project as separate files in JPEG format attachments in the application email, or on a Thumb Drive, which demonstrate your ability to meet the defined project opportunity. Applications with more than 10 images or artwork examples will be disqualified.
