Boise City Invites Community to Submit Creative Works for Purchase for the Boise City Archive to Document Life During Covid-19

Deadline: 9 August 2020, Midnight MST

Budget: 30 works will be purchased for \$500 each, totaling \$15,000

Opportunity

Boise City seeks to purchase original visual art, literary works or photo documentation of performative or digital works which serve to document or respond to the Covid-19 Pandemic of 2020. Selected artworks will be accessioned into the City of Boise's Archive. All artworks must be two-dimensional, on paper, no larger than 50" by 30" in either direction and must relate to life in Boise during the pandemic. All 2D, paper media will be considered including painting, drawing, photography, printmaking, written word, photo documentation of performative work, and more. Each applicant can submit up to four (4) works for consideration. The price of each artwork shall not exceed \$500.00 to ensure the City can acquire a collection of works which serve to document a broad perspective from the community.

Background

Our everyday experiences are important to document, but in times like the current COVID-19 pandemic, reflecting upon our everyday experiences becomes more important.

During these unprecedented times, it is important for our community to document their experiences for future generations through a creative lens and to provide some space for the healing that comes from self-reflection. These creative works will strengthen our community and aid our ability to come out of this experience stronger and closer as neighbor, while helping future generations understand this unique moment in time.

Statement on Equity and Inclusion

In 2017, the Arts & History Commission endorsed a statement on cultural equity. In recognition of the initiative, the Department of Arts & History will strive to accession works into the collections which serve to reflect the rich and diverse past, present, and future of the Boise community.

"To support a full creative life for all, Americans for the Arts commits to championing policies and practices of cultural equity that empower a just, inclusive, and equitable nation." Cultural equity embodies the values, policies, and practices that ensure that all people—including, but not limited to, those who have been historically underrepresented based on race or ethnicity, age, disability, sexual orientation, gender, gender identity, socioeconomic status, geography, citizenship status, or religion—are represented. Cultural equity is critical to the long-term viability of the arts sector. The prominent presence of artists challenges inequities and encourages alternatives.

All application materials must be submitted in one email with all images and documents included as attachments, not embedded in the email message. PDFs containing all materials will not be accepted. ALL APPLICATIONS MUST BE SIGNED. The Owner of the application, once submitted, is the City of Boise.

The Application package shall contain the following information:

1. Application Form

Fill out and sign the **Application Form**/Signature Page and submit as your first document.

2. Work Statement

Please submit a brief statement about your current practice and working process, not to exceed 250 words.

3. Applicant Bio

Include a brief statement about yourself and any relevant qualifications or accolades, not to exceed 150 words.

4. JPEG Images of Existing and Available Works

Images are to be in JPEG Format, 300 dpi, not larger than 10" on the longest side. Provide up to four images of your existing, available work as separate files in JPEG format attachments in the application email, or on a CD or Thumb Drive enclosed in the application envelope, which demonstrate your response to the Covid-19 Pandemic.

5. Image List

Please use the provided form to list the information for the submitted images: title, type of work (painting, drawing, photograph, etc.), material(s), dimensions, date and use the work statement section to provide a statement about each individual work, not to exceed 150 words each. The form can be adapted or transferred to another file type as long as all of the required information is included.
