Questions and Clarifications:

Q1) Is there a target number of artists you hope to have on the final Artist Roster, and will artists be added to the roster over the 5-year time frame?

A1) The goal is to qualify as many artists as possible. There will not be any artists added over the 5-year time frame.

Q2) Will a selected candidate be able to provide an updated portfolio over the course of the 5 years, or will this just be available to a client via websites/social media links?

A2) Decisions will be based off of original submittals, however if selected for a project, artists are free to show current work and openly discuss design concepts.

Q3) Approximately how many projects are anticipated over the 5-year timeframe, or perhaps on an annual basis?

Q3) It is expected, but not guaranteed, that VRT will have approximately 12 projects annually. Q4) How important is past experience in public art?

A4) If an artist has this experience, it should be highlighted. However, if an artist does not have this experience, then it is expected that other areas of experience where working with others to achieve goals and a similar vision are highlighted. VRT desires true artwork, as opposed to advertisements and targeting 2-demensional experience.
