# LOOKING FORWARD

### America 250

The City will begin its celebration this August at the Hayman House with American Contradictions: Exhibition for the Boise Visual Chronicle, a juried art exhibition featuring local artists who have responded to a prompt related to the challenges inherent in American history.

The City of Boise's America 250 celebration will take place primarily between January and July 4, 2026.

The details are still in progress, but Arts & History is leading this effort with the help of the Office of Community Engagement. Possible events and exhibits include:

- Essay, Song, and Art Contest for Youth through community partnerships;
- Exhibitions at JUMP through the Smithsonian Institution;
- Five Nights of 250 Community discussions;
- Audio Minutes Boise Place Names, through partnership with Boise State University and Idaho Matters;
- Digital Reader Boards, Valley Ride Transit;
- Deaf Education History Exhibition, James Castle House;
- Women's Labor History Exhibition, Erma Hayman House; and

 Trivia Nights – in partnership with Idaho State Museum and Idaho Public Television.

### Smithsonian in Boise

In May, I was asked to be part of the first cohort to attend a summit for the Smithsonian Institution's (SI) Rural Initiative. The SI is investing in being a resource for the entire United States, and its leader, Lonnie Bunch, is committed to taking the Smithsonian to the people rather than citizens merely thinking of the Smithsonian as a place to visit in the nation's capital. In particular, SI is committed to putting SI resources into Idaho, where it currently has a disproportionately small footprint. Even more on point, they would like to help Idaho celebrate the America 250.

During the summit, several SI leaders gave presentations about their programs and how communities like Boise can engage the SI and leverage its name recognition. While many of the opportunities were intriguing and relevant, presentations from Folklife Festival staff felt like the best fit for the City of Boise's mission and values and the best near-term way to engage with SI. In listening to the Boise community over the past few years and recognizing the cultural riches brought to Boise through 50 years of refugee settlement, it seemed that hosting the first ever Boise Folklife Festival would be an opportune means through which to highlight and elevate these cultures and support both the refugee, native, and traditional folk-art communities throughout the Boise Valley and beyond.

The SI website describes the festival as such:

"The Smithsonian Folklife Festival, established in 1967, honors contemporary living cultural traditions and celebrates those who practice and sustain them....

Our Festival takes place every summer on the National Mall, with free performances, workshops, demonstrations, and other activities. It is an educational, research-based presentation that features master artisans and other tradition bearers. We invite visitors to sing and dance along, try crafts and games, learn traditional recipes, ask questions, and take part in this unique cultural exchange."

The first step will be a September 24-25 convening in Boise. We will invite 25-30 community members to join us at City Hall for 1.5 days to hear from the Smithsonian Folklife Festival team. The Folklife Festival team uses an incubator model to assist communities around the country with initiating their own local folklife festivals, and they will share their template for planning and executing a Folklife Festival right here in Boise.

# COMMISSION REVISION UPDATES

Legal is currently working on changes to the Boise City Ordinance to enact the following changes:

1. Increase the number of commissioners from seven (7) to nine (9), which will still include one voting student commissioner.



- 2. Add clarifying language requiring that the Arts & History Commission provide recommendations to City Council for projects exceeding \$50,000;
- 3. Add language directing said recommendations to be placed on City Council's consent agenda accompanied by a written staff memo;
- 4. Add language identifying the commission's role in promoting the public interest and civic engagement through the department's professional work.

Additionally, the City Attorney's office is also drafting bylaws that will outline clear expectations for commissioners, based in large part on the feedback we received from our interviews with you last year.

# **GENERAL FUND PUBLIC ART PROJECTS**

### **Boise Visual Chronicle 2025**

\$20,000; The BVC will take the form of an exhibition this year, opening in August 2025 and installed at the Erma Hayman House. This will include a jury that will award 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> awards, as well as a purchase award. Each artist selected for the exhibition by the jury will receive a small stipend for framing/display and will be able to offer their works for sale during the exhibition. Eight artists were selected by the jury and have begun work. Exhibition opening reception August 28<sup>th</sup>, 6-8pm.

# **CCDC PROJECTS WITH TYPE 4 AGREEMENTS**

**521 W Grove St. Public Space, Public Art** \$731,322 (artist budget, \$491,100); **complete!** 

Artist team Hua Studio (Huameng Yu and Louis Chinn) are continuing to collaborate with CCDC, the site design team, architects, engineers, and the construction team as their works complete fabrication and begin to installation at the site. The artists are in Boise to assist with the installation process and will be in town through the dedication of Kaixo Corner (July 28 at 4:00 pm).



# **Linen Blocks T4 ArtPort Installation**

\$20,000 2nd art port sculpture installed on Grove St. between the 10<sup>th</sup> and 11<sup>th</sup> blocks. Partnership with sculpture class at BSU to select and display student artwork. Installation took place May 5<sup>th</sup>, 2025. Artist Grace Ott's sculpture One Man's Trash Responds to the statistic from the City of Boise's Climate Action Roadmap describing the average amount of waste from each Boise household per month, Ott's work features a Cooper's hawk on its nest atop a 138-pound pile of trash.



### **Traffic Boxes 2025**

\$42,500; 16 artists selected for new traffic boxes to be wrapped in summer of 2025. Boxes are located within CCDC's Westside Urban Renewal District. Selected traffic boxes are currently being wrapped and will be completed by September 1st, 2025.

# Warm Springs Golf Course Asphalt Mural Invitational

\$32,000; Project in conjunction with the opening of the new Warm Springs Golf Course Clubhouse. Traffic calming asphalt mural at the intersecting pathways of the Greenbelt and Warm Springs aolf cart pathway. Selected artist Andie Kelly designed a piece that mimics a flowing river, steam rising from geothermal springs, and golden currant blossoms scattered throughout. Mural installation set for mid-June 2025.

# MAJOR ACCOMPLISHMENT UPDATES

# **CCDC T-4 Deferred Maintenance Reimbursement Approval**

In partnership with the Capital City Development Corporation (CCDC) through a Type 4 Deferred Maintenance Agreement, several key public artworks have recently undergone successful maintenance and repair. This collaboration allowed for critical preservation work on Botanica, Integration Mural, Bicycle Trio, Idanha Canopies, and, most notably, Grove Street Illuminated & Boise Canal by artist Amy Westover.

As part of this effort, Westover oversaw significant material improvements to her 2003 installation located at 9th and Grove. The original steel and plexiglass utility covers, which had experienced repeated material failure, were replaced with more durable cast bronze elements. The work was thoroughly documented, and CCDC has agreed to reimburse the associated maintenance expenses.



This project represents a successful collaboration between city departments, CCDC, and the artists involved, ensuring the continued safety, integrity, and visual impact of these valued public artworks.

# MAJOR ONGOING MAINTENANCE UPDATES

# **River Sculpture Damage**

On June 26, a traffic accident resulted in damage to the *River Sculpture* located in front of the Grove Hotel at Front Street and Capitol Boulevard. One of the vehicles involved struck an adjacent planter, which then slid into the base of the sculpture, damaging one of the granite façade slabs. This is the second traffic-related incident affecting the sculpture in the past year.

Damage has been documented, all pieces have been collected, a police report has been filed, and an insurance claim is underway. We are exploring options to repair the sculpture using salvaged granite currently in storage.

The recurring nature of this type of damage has prompted us to begin evaluating potential mitigation measures to protect the artwork going forward. Additionally, this incident may impact ongoing efforts to inspect, repair, or upgrade the sculpture's LED lighting. There is also a planned



treatment to thoroughly wash and seal the façade to enhance the granite's color and longevity.

We will keep the Commission updated as we gather more information and move forward with next steps.

### **Ariana Martinez Residency**

The James Castle House said farewell to Ariana Martinez after a wonderful 10-week term. During their stay, Ariana connected deeply with the Boise community and was able to rediscover ways of working that had been long dormant. Ariana hosted three open studios, one intergenerational workshop, and one final presentation at the James Castle House, where the community had the opportunity to meet them and see their work. We wish Ariana the best of luck in their future endeavors!

# Persona and Place: Artists and Sites of the Historic Artists' Homes and Studio Program

Historic Artists' Homes and Studios Director Valerie Balint gave a fascinating presentation where she guided attendees through a visual journey of artists across three centuries, exploring how portrait photography and preserved spaces offer insight into their lives and legacies.

This engaging talk placed James Castle and his Boise home within a broader national context, connecting his story to other iconic figures and preserved sites in the Historic Artists' Homes and Studios (HAHS) network.



# Coffee with a Curator

The Erma Hayman House hosted an interactive event with curator Katie Knight to dive into the Speaking Volumes: Transforming Hate exhibition. Attendees discussed the artworks and their reactions to them, exploring the themes presented in each one and enabling a thoughtful dialogue.





# **Taste of River Street**

The Erma Hayman House partnered with Kin chef Kevin Heulsmann for a fantastic tasting event featuring recipes inspired by the original River Street Neighborhood Cookbook. This cookbook was compiled by Dorothy Buckner in the 1960's and 70's with recipes donated by families throughout the River Street Neighborhood.





### **IHC Summer Institute**

The Erma Hayman House hosted Idaho Humanities Council Summer Institute where 25 educators from around the state learned more about EHH and the Historic River Street neighborhood. They explored how art can provide a platform for engaging in hard conversations, and learned how to make a zine to share a personal perspective. The IHC's goal of the Institute was to empower teachers to tell full narratives of Idaho's history and help them learn to research the stories and experiences of black Idahoans.

# **Arts & History Grants Program**






#### LENGTH OF TIME IN BUSINESS


#### **ANNUAL BUDGET**






#### FULL-TIME EMPLOYEE COUNT




#### PART-TIME EMPLOYEE COUNT











What resources, training or other support would help your organization address challenges and capacity issues?







### CONFLUENCE AT WARM SPRINGS GOLF COURSE: UPDATE


- Artist Andie Kelly installing mural June 16- July 3, 2025
- Located where the Warm Springs Golf Course pathway meets the Greenbelt, this mural reflects the natural flow of the Boise River and nearby geothermal springs. Deep blues and soft greys evoke water and steam, while golden currant blossoms represent native riparian plant life. With fluid forms and a soothing palette, the piece invites a quiet moment of connection to Boise's unique natural landscape.





# PASSAGE AT REDWOOD PARK: UPDATE

Passage, a public artwork by James Peterson of Art + Contraptions is near completion. Construction and installation of the work is wrapping up in Redwood Park and the artwork will be accessible for the June 7th Ustick in Bloom event. The project will be highlighted through brief remarks during the event.







#### PROJECT BACKGROUND

- Funded by the Neighborhood Investment Program and the City of Boise's Percent for Art Ordinance
- Redwood Park in residential area and hosts the West Valley Neighborhood's Ustick in Bloom event
- The selection committee developed shared thoughts on the identity of their community:
  - Nostalgia
  - A neighborhood/community redefining its identity amid rapid urban development. Acknowledge this tension between its past and future
  - Desire to honor the history of this neighborhood/community
  - Desire for iconic, yet approachable public art, possibly with interactive elements
  - A community anchored by their roots, but inspired by opportunities for growth
  - The park is high traffic, used by neighbors for meeting spots, dog walks, and has a bike path at one edge




"Passage draws its inspiration from the beauty of nature and the delightful experience of strolling among apple orchards, paying homage to the agricultural heritage of Ustick. This artwork aims to weave a sense of tranquility into a narrative that vividly mirrors the past and present-day growth of the area. 




## KAIXO CORNER PUBLIC ART PROJECT UPDATE

The October 2024 RFQ asked applicants to consider the following statements:

- The new public space intends to recognize and celebrate the history, contributions, and cultures of the diverse populations from the Old Boise neighborhood.
- There were many immigrant people in this area whose stories are not currently visible, but whose impact on Boise was indelible.
- Immigration in Boise mirrored larger immigration trends throughout the United States but were also impacted by specific local urban development patterns.

A selection panel consisting of a City Council member, Arts & History Commissioner, CCDC representative, local artist, and local community member, selected a new artist in December 2024.





Artists Louis Chinn and Huameng Yu are inspired by the rich and storied history of Boise. The multitude of hands and cultures that have shaped and built this place over many eras has led to a layered tapestry of voices that are both visible and hidden from modern memory. It is a place defined by a spirit of independence, resilience, and legacies of forging unlikely paths forward. The artworks at Kaixo Corner create a map of migration, culture, and ecology, inviting visitors to journey through both space and time, and across stories, memories, and dreams. These artworks honor the people who shaped this neighborhood and embedded their presence into the culture and the land.

# BOISE VISUAL CHRONICLE 2025: UPDATE


The BVC will take the form of an exhibition this year, opening in August 2025 and installed at the Erma Hayman House. This will include a jury that will award 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> awards, as well as a purchase award. Each artist selected for the exhibition by the jury will receive a small stipend for framing/display and will be able to offer their works for sale during the exhibition.

Eight artists were selected by the jury and have begun work.



# BOISE DEPOT 100 PROJECTION: COMPLETE

- Artist team Annika Kalac and Will Miller were selected for digital projection art for temporary display on the Boise Depot across 4 days. They collaborated with a contracted projection professional and developed artwork for display that varied daily. Their artwork was also informed by an activity at last year's Open Streets event.
- The artists collaborated with a projection consultant, Casey Nova of Lumenarius.
- Their artwork was successfully displayed during the Boise Depot Centennial celebration event from April 13, 2025 April 16, 2025, gathering a crowd for the "Flip the Switch" kick-off event, as well as each evening for nightly viewing.
- The Depot Centennial event saw an estimated 7,000 visitors total, with about 150 visitors each night, just for the projection.





#### LINEN FENCE 2025: COMPLETE

- Local artist Liz Hilton completed work for the 2025 Linen Fence
- Made from vintage and modern publications, acrylic paint, charcoal, and epoxy resin on wood panel, this artwork reflects the passage of time through the evolution of the age of the materials and the progression of walking chickens. The work encourages viewers to look back at where we have been so we can more insightfully choose where we go from here.





## DAUGHTERS OF THE DUST: COMPLETE

- Gracieux Baraka's vinyl murals, Daughters of the Dust, were installed at the Erma Hayman House and Main Library. The artwork will be displayed for 6 months.
- Baraka saw his sister Francine reflected in the life of Erma Hayman. Both artworks reflect the lives these women, and the ways we construct identity.
