## **GENERAL FUND PUBLIC ART PROJECTS**

### **Boise Visual Chronicle 2025**

\$20,000; The BVC takes the form of an exhibition this year, **now on view** until March 2026 at the Erma Hayman House. The Jury has awarded 1st, 2nd, and 3rd awards, and a purchase award has been selected. Each artist selected for the exhibition by the jury received a small stipend for framing/display and their works are offered for sale during the exhibition. Eight artists in total are in the exhibition. Below is an image featuring artworks in the exhibition, the artwork by Margaret Pope on the far left in the image is the 2025 purchase award.



### PUBLIC WORKS PUBLIC ART PROJECTS

### 2026 ArtPort Program


\$20,000; Annual program in partnership with BSU Sculpture class, now in its 3<sup>rd</sup> year. The artwork currently installed on Grove St. at the Modern Hotel will be rotated out for a new artwork this year.

### 2026 Traffic Box Art Program

\$30,000; Annual program and call. The call for artists closed on October 15, 2025, and 9 artists were selected for installation in summer 2026. This year, artists were invited to explore the intersection of community and climate action in their artwork - inspired by one of the Climate Action Roadmap priorities, with a special focus on how shared action, collective resilience, and neighbor-to-neighbor connection shape our response to climate change, offering a hopeful or solution-oriented perspective.

### Water Conservation & Resiliency Public Art Project

\$330,000; Public Art Project has been re-located at Camel's Back Park. The official Request for Qualifications and application period has closed, and the selection process is underway. The selection panel includes community stakeholders, Parks and Rec staff and Public Works staff. This goal of this project and resulting artwork is to raise public awareness about the region's contemporary water challenges as well as conservation and resiliency efforts. We are seeking dynamic, experiential public art that will inspire thought, provoke discussion, and elicit action. Artists with experience in environmental design, kinetic, or haptic outdoor installation are especially encouraged to apply.. Installation expected Fall of 2027. Image below shows the site location for the project at Camel's Back Park.





### AIRPORT PUBLIC ART PROJECTS

### ConRAC (Consolidated Rental Car Facility)

\$308,700; Vinyl banner mural installation on façade of the ConRAC building, with installation to occur alongside opening of facility in Spring 2026. This will be the first iteration of rotating installation every 3-5 years. Working with Trademark on the installation mechanism and plan. Images below show where there will be artwork. Artist Chad Otis has been selected by the selection panel. His application and proposal best embodies the project goals and prompt: In 2026, The Boise Airport will celebrate its 100-year anniversary, and the United States will celebrate its 250-year anniversary. We asked artists to consider: While acknowledging the past years of history, what could the future of air transportation in Boise look like? How would you represent that in your artwork?



#### Concourse A – Integrated Public Art

Budget under development; Multiple opportunities have been identified in the new Concourse A schematic design phase. Early identification of artwork locations/opportunities will aid in integration of artwork installation and structural needs during engineering and construction planning. Intend to release an RFQ in early Spring so artists are part of the design team and create works as a cohort. The concourse project has a 5-year timeline currently.



### **ACCOMPLISHMENTS OF THE MONTH**

### **New Website & Digital Public Art Collections Access**

Since 2022, the Collections Management team has been transitioning our collections management software from Proficio to Public Art Archive (PAA). PAA serves as both a centralized repository for essential collections management documents and a public-facing platform, allowing the community to view artworks even when they are not on display.

The collection is viewable on the newly launched Arts & History website. As of November 24, all Site-Based Works including artworks in Parks, Libraries, Watershed, and Boise Airport—as well as the James Castle House Artist in Residence collections have been published. Additional collections will be complete over the coming months.



### Repair to River Sculpture

On June 26, a traffic accident damaged the granite façade of the *River Sculpture* located in front of the Grove Hotel at Front Street and Capitol Boulevard. This marks the second traffic-related incident affecting the sculpture within the past year.

Replacement granite for this piece is no longer available, so the damaged stone was collected and reconsolidated by Alaggio Laurino. On November 14, the reconsolidated stone sections were reinstalled by Tim Hendrix and Matthew Thorley. Some areas of loss still require additional infill and inpainting to reduce visibility.





Vehicular impact has proven to be an ongoing concern for this site and artwork. Due to limited availability of granite, repeated repairs are not a sustainable long-term solution. The Collections team is exploring alternative strategies to mitigate future damage in collaboration with Planning and Development Services (PDS).

### Janhavi Khemka Residency

Janhavi Khemka's residency at the James Castle House was a wonderful experience for our community, especially those who are Deaf or Hard of Hearing. Born in India, Janhavi only began learning ASL in 2021 after moving to Chicago. She delivered her first presentation in ASL on November 6<sup>th</sup>, to an audience of 40 people, most of whom were Deaf. The presentation was among the best we have ever hosted.

Janhavi's stunning work will be added to the City of Boise's permanent public art collection in the form of a first-edition woodblock print as well as a digital projection inspired by her time onsite.



### Taste of River Street

The Erma Hayman House hosted our second Taste of River Street event, honoring the diverse food traditions that shaped Boise's River Street neighborhood. This special gathering featured a prix fixe menu created and curated by Chef Kevin Huelsmann of KIN, inspired by the River Street Center Cookbook, a compilation of former River Street resident recipes and culinary customs. This program will continue in 2026.



### Where Art Begins: Artists Creative Spaces Panel Conversation

The James Castle House hosted an engaging conversation with several Boise artists about their creative practice and the spaces they create in. William Lewis, Marianna Jiminez Edwards, Michael Candelaria and Rachel Teannalach shared more about how they craft spaces in which a creative practice can thrive.





#### Be A Maker

Be A Maker wrapped up this season with a multi-generational workshop at the James Castle House. Boise artist Amy Nack taught attendees the printmaking practice of collagraphy.



### **Echoes of Home**

The James Castle House opened our new exhibition of community-owned works with a public reception on November 20<sup>th</sup>. In this exhibition, we expand our exploration of James Castle by shifting the focus from the artist himself to the community members who have formed deep connections with his work. For decades, Boise-based collectors have been drawn to Castle's enigmatic and evocative creations — works that speak to a profound sense of place and personal resonance.

Echoes of Home highlights the powerful bond between Castle's art and the people who have chosen to live with it. Featuring pieces from private local collections, this exhibition reveals the diverse range of Castle's work that has found its way into Boise



homes — and into the hearts of those who cherish it. Echoes of Home will be on view until May, 2026.

### **Arts & History Grants Program**

<u>FY26 Arts & History Grant award recipients</u> were announced on September 23, 2025. 44 recipients will receive funding to total \$120,000 for cultural projects that occur between October 1, 2025, and September 30, 2026, and benefit Boise residents. ### **Summary**

Archives program has continued to work alongside the Office of the City Clerk to prepare the records & archives facility opening to the public for research. We are holding an open house for select city-staff during the month of January. Additionally, archives staff have been working towards increasing digital access to collections and supporting multiple research projects of other city departments as well as Boise State University.

### **Digital Collections**

Archives is working with a local vendor to reformat the permanent record of City Council meeting minutes from cassette tapes to digital preservation file formats. Cassette tapes are considered high risk for loss of records due to rapid deterioration of magnetic media. These minutes will be uploaded to our digital collections platform, Quartex, for access once the project is complete.

Also, staff imaged and uploaded a new album of early days Boise. This album was transferred to us from the Boise Public Library.
